**ORDER**

**Dated 03.08.2020**

As per the directions of Hon'ble Chief Justice, Gauhati High Court issued vide Notification No. 53 dated 31.07.2020, the following guidelines for Dhemaji District Judiciary are issued until further orders:-

- It is hereby directed that only cases of emergent nature involving personal liberty, viz. bail matters, remand matters, recording of statements under Section 164 Cr.PC, Zimma Petitions and other matters involving utmost urgency in which there is a genuine need for stay of some action, would be listed for hearing. In such cases, request for listing and hearing may be made by the concerned counsel, which would be considered, considering the nature of urgency of the matter. A request is made to learned counsels not to press for hearing of cases which are not of emergent nature.
- Filing of all cases, however, would be permitted in all Courts.
- It is further directed that no person from "containment zones" or "quarantine areas" will enter the Court Complex.
