ORDER

Dhemaji dated 16.03.2020

Pursuant to the Order and Notification No.11 dated, Guwahati the 15th of March 2020 of Hon'ble Gauhati High Court and as per the direction of Hon'ble Chief Justice of Gauhati High Court, Guwahati regarding prevention and spread of Novel Corona Virus (Covid-19) disease, the following arrangements have been made in the Dhemaji District Court until further order:

- All the courts under the Judgeship are requested not to insist on the presence of the parties until and unless inevitable. Further, all the officers under the Judgeship are requested to restrict entry of litigants and the general public in the court complex as far as possible to avoid crowding. It is further requested to use the video conferencing facility for appearance of accused in custody, statement of victim, recording of evidence, etc. Also, in final argument matters, a written submission may be called for to be submitted in the court and the time for oral arguments may be reduced to the extent possible.
- The Deputy Commissioner, Dhemaji is requested to provide Thermal Scanner for the purpose of detection of COVID-19 virus for the General public/Litigants/ Advocates and all other persons visiting Dhemaji Court Complex and also other necessary logistic support.
- The Superintendent of Police, Dhemaji is requested to take up appropriate measures to restrict unnecessary footfall of litigants and general public in the Court Complex and to depute adequate police personnel at the entry gate of District Judiciary, Dhemaji and Dhemaji District Bar Association. Freshly arrested accused shall preferably be produced by the concerned Judicial Magistrate through video conferencing.
- The Joint Director of Health Service, Dhemaji is requested to depute a medical team in the office of the District Judiciary, Dhemaji to create awareness about the Novel Corona Virus (Covid-19) to the Judicial Officers, Court staff and members of the Dhemaji District Bar Association and necessary health check-up.
- The Superintendent of District Jail, Dhemaji is requested to curtail unnecessary crowding and instead of the physical production of under trial prisoners from jail, video conferencing facility may be availed.
- The President/Secretary of Dhemaji Bar Association is hereby requested to comply with the Hon'ble Gauhati High Court, order and instructions with a request to create awareness amongst all the members of the Bar regarding spread of Novel Corona Virus (COVID-19).
- The Secretary, DLSA, Dhemaji is requested to cancel all awareness meetings under DLSA, Dhemaji, until further orders.

- The Supplier of this office is asked to supply and install adequate numbers of Washbasins along with hand sanitizers and hand washes within the Court complex.
- All the Officers and employees under this Judgeship are requested to take care of the cleanliness and hygiene within the Court complex along with special attention to their personal hygiene.
- The entry of any foreign national in courts and offices is strictly restricted until further order(s)
- A Monitoring Committee headed by Secretary, DLSA, Dhemaji is formed to look into and oversee compliance of all the instructions given herewith as per Hon'ble Gauhati High Court order dated 15th March 2020.
